

# You Can Support CHCS Scholarships Using Your Ohio State Tax – At No Additional Cost

*Ohio offers a tax credit that lets you redirect a part of your state taxes that you are already pay to student scholarships at no cost to you.*

20. Tax due (line 13 minus line 19). If line 19 is negative, ignore the "+" and add line 19 to line 13 ..... 21. .....  
21. Interest due on late payment of tax (see instructions) ..... 21. .....  
22. **TOTAL AMOUNT DUE** (line 20 plus line 21). Pay electronically at [tax.ohio.gov/pay](http://tax.ohio.gov/pay) or include the Ohio Universal Payment Coupon (OUPC) with your check ..... 22. .....

## Here's how to do it.

**13.** This is how much you can donate to OCEN and receive the full amount back up to \$750 individually and \$1500 filed jointly.

**16.** This is where you show the amount donated to OCEN for a full refund from the Ohio Schedule of Credits Form line 15.

## Step by Step Instructions\*

### Step 1.

Take this to your accountant and let him know you would like to make this donation or if filing yourself see line 13 on your State of Ohio form. You can donate this amount at no cost to you! (Hint: If you make over \$40,363 individual or \$67,636 filing jointly you can make the full \$750 per individual donation.)

### Step 2.

Scan the QR code below and make the donation directly to Ohio Christian Education Network in Chapel Hill's name.

### Step 3.

Print out the receipt and include with your Ohio Schedule of Credits. Make sure the tax ID 31-1787824 is on that receipt.

### Step 4.

File your return and you will get back 100% of the money you donated up to \$750 per individual.
